*Manuscripts.*—Manuscripts should be typed double spaced on standard 8 x 11 bond paper. A limited number of half tone and line drawing or graph illustrations can be reproduced without additional charge. Colored illustrations must be financed by the author or his institution. The maximum space for halftones is 5 x 7½ inches (127 x 190 mm.).

Manuscripts will be accepted for publication on condition that they are contributed exclusively to THE JOURNAL OF HISTOCHEMISTRY AND CYTOCHEMISTRY.

The editor suggests that consideration of manuscripts will be expedited by inclusion of a carbon copy, but does not require this. The editor will accept any variant spelling recognized by current standard dictionaries, but requests that each author be consistent in his use of such words. The editor has no requirements as to style, but reserves the right to suggest changes which will clarify or condense. The use of groups of initials of syllables or words to designate chemical substances or technics will be discouraged unless the abbreviations thus created have achieved dictionary recognition. If acronymous abbreviations can be made into pronounceable words, such as "dopa," this appears preferable.

References will include surname and initials or given names of authors, the title of the paper cited, the abbreviated name of the journal, the volume number, inclusive pagination and year, and in the case of books, author's name, title, edition, publisher's name and city, year, and if necessary, specific volume, chapter or page references.

References should be alphabetically arranged by the surnames of authors, and papers by the same author chronologically arranged. References may be numbered if the author desires, to facilitate reference to a number of minor references in the text regarding the same finding.

*Reprints.*—An order blank, together with a table listing cost of reprints, is sent with proof. No reprints are furnished gratis to contributors. Orders for reprints should be sent to the printer.

*Subscriptions.*—The subscription price for THE JOURNAL OF HISTOCHEMISTRY AND CYTOCHEMISTRY is \$7.00 per volume in the United States and the postal union; \$7.50 in countries outside the postal union; single copies, when available, \$1.50.

Subscriptions of members of the Histochemical Society are included in the membership dues.
